No work is normally allowed after 18.00, Monday to Friday, on Saturday afternoons or on Sundays and public holidays.

Whenever possible, we will notify local residents of any variation to the above hours or work that might cause unusual disruption, such as out of hours deliveries.

## **COMMUNITY NEWSLETTER FEBRUARY 2024**

## THE YEAR AHEAD

We have now been on site at St John's Wood Square for 17 months. Having made a tremendous amount of progress, we wanted to take the opportunity to share what you can expect on the site for the next 12 months as we complete the demolition phase and move into construction of the buildings above ground.

All site demolition works will be completed by the middle of the year, with 1-7 Oueen's Terrace one of the final areas to complete. Alongside this, the basement excavation and earth removal work will be finished.

The second half of the year will see the focus shift to the construction of first new building structures above ground using concrete frame construction as the new development begins to visibly take shape above ground. This will include piling and construction of the new 'Block 9' on the corner of Queen's Terrace and Queen's Grove. This progress to the

construction phase will see a much higher number of people working on

By the end of the year we will start to install the external building finishes to the first new buildings, starting with 'Block 5' in the north-east corner of the site, next to Ordnance Hill. This will mean the installation of brickwork, Portland stone and windows, ahead of commencing the internal building works in 2025.

Alongside all of the new construction activity, we will also start the specialist restoration of the Grade II listed Riding School's brickwork and roof structure this year, ensuring this building gets the treatment it needs to become a long-term feature for the area and reminder of the site's

All major works are currently on track, and it is still the intention to complete the development by early 2028, ready for new residents to move it.

Before this, I worked on other residential and commercial sites, including in the St John's Wood area.

## SATURDAY WORKING

Under our agreement with Westminster City Council (WCC), we are permitted to work on Saturday mornings between the hours of 8am and 1pm.

There are certain types of activity that WCC feels are acceptable on a Saturday including removal of spoil or waste from the site, deliveries, and quieter construction activities such as operation of the tower crane to move material around the site. We always steer away from activity such as percussive demolition works.

Being able to carry out some quieter activities on Saturdays means we can prepare for the week ahead and helps to keep our construction programme on track so that the development is completed on time.

We will always try to be considerate of our neighbours when working on Saturdays and will aim to notify you of any work that might cause unusual disruption

## WHAT'S HAPPENING ON SITE: PROGRESS TO DATE

## **JANUARY 2024**

We have made significant progress on the site over the past 12 months, having completed the demolition of all the structures on site, finished piling works for the main basement and commenced construction of the new basements and ground level structures in preparation for construction of buildings above ground to commence later in the year.

In early January, we moved our Site Control Centre to the southern part of Queen's Terrace to accommodate the 150 people currently working on site. This houses our welfare accommodation and will be in place until the development has been completed.

We are now just over halfway through the excavation works, which are due to conclude in 2024. We are now pouring the concrete slabs that will form the ground floors of the new buildings.

The image opposite and key below explain what has been achieved to date and where we are currently working in the site.

#### **SITE ACTIVITY KEY:**

- The main site gate on Queen's Terrace this will be moving south on Queen's Terrace later in the year.
- The Riding School during 2023, the Riding School building had its foundations underpinned and is currently having a new basement structure constructed.
- Building 5 Top-down construction having completed the ground level structure last year, McGee is working beneath it to safely complete the Building 5 basement.
- Town house footings work is ongoing at the new building 7 lower level. A line of steel props temporarily support the roadway on Ordnance Hill while the new basement structure is built.
- The main basement dig in the middle of the site work continues to excavate the basement of the new buildings (3 and 6) with excavation continuing to the south and east.
- Avenue top-down construction the 'Avenue' will be an elegant, tree lined vehicle and pedestrian access in the completed scheme. The roadway in the photo will be extended across to Queen's Terrace to creating a bridge for construction traffic while the basement is being built.
- The west cofferdam works behind the hoarding on Queen's Terrace the cofferdam construction method, with its two lines of piled walls and enormous yellow temporary propping, is being employed to safeguard the TFL tunnels the run beneath.
- Our Site Control Centre this facility has now been installed on the southern part of Queen's Terrace and will remain there for the duration of the construction process.

# FAÇADE RETENTION WORKS ON QUEEN'S TERRACE

January saw the start of the demolition of 1-7 Queen's Terrace, on the corner with Queen's Grove. As part of the development, this building is being rebuilt and extended to provide a new residential building. A key part of this process will be the retention and restoration of the historic building facades on the Queen's Terrace and Queen's Grove frontage.

The buildings were originally built in the 1840s as part of a longer terrace that ran along Queen's Terrace. Part of this terrace was demolished to make way for the Jubilee Buildings, which were part of the

Barracks. The remaining buildings were extensively refurbished in the 1980s and in 2002, leaving minimal original features inside.

One of the most significant external features is the original St John's Tavern sign on front of the building. This is being carefully protected in place and will be incorporated as a detail of the new building.

The deconstruction of the internal structures will be completed as carefully as possible. These works are expected to last until June/July 2024, after which point the new building construction will commence.

While the façade retention work is taking place, the northern part of Queen's Terrace will be closed to vehicles during the week (Mon-Fri), however it will be accessible at weekends. The intention is to fully reopen the road at the end of February 2024.
